- 1. Table of awarded special item number: SIN A-25g.
- 2. Minimum order: None.
- 3. Quantity/Tier discount(s): 3% discount off the FSS Price List for a single order (non-BPA) of 12 or more pairs of same SKU. 5% discount off the FSS Price List for a single order (non-BPA) of 36 or more pairs of same SKU.
- 4. Geographic coverage: 48 states, including Washington, DC and point of exportation to Alaska, Hawaii and Puerto Rico.
- 5. Point of distribution: Teaneck, New Jersey.
- 6. Payment terms: 2% 20 net 30 on all purchases over \$3,000.00 (excluding credit card payments).
- 7. Government credit cards accepted up to, at and above the \$3,000.00 Micropurchase Threshold limit with no maximum limit.
- 8. Time of delivery: 14 days ARO (After receipt of order).
- 9. Expedited delivery time: 48 hours ARO on all in-stock products. The government to pay for the difference between Standard Delivery and Expedited Delivery charges.
- 10. Ordering/Payment address: 414 Alfred Avenue, Teaneck, New Jersey 07666.
- 11. Warranty & Returns: Apex footwear has a 30 day customer satisfaction limited guarantee. Apex will replace or issue a credit at the VA purchase price within 30 days of customer's purchase for Apex footwear. With your purchase, Apex will include a return packing slip and a prepaid return shipping label for qualifying Apex Footwear. If you are missing your return packing slip or shipping label, please contact the Apex Returns Department by calling 800.252.2739 or emailing returns@apexfoot.com for a replacement. You will not be charged a restocking fee as long as the purchase was within 6 months. For all other products, if the return is due to shipping error or manufacturer defect, Apex will provide prepaid shipping labels. Other incidents such as ordering errors will be evaluated for credit and will be subject to a restocking fee. Exchanges or credits will not be issued for special make-up items, i.e. individual Ambulator Shoes (each), custom orthotics, etc. If an item is accepted for credit, a credit memo will be issued within 10-14 days of receipt of return. Items that do not qualify for credit will be returned to the customer at their expense. FREIGHT CLAIMS AND SHORTAGES
